The Road Less Travelled Ltd reserves the right to insist on a medical certificate from my Health Practitioner, stating that I am medically and physically fit for my chosen trip. If I suffer from heart, chest, muscular, neurological or respiratory disorders, severe asthma, high blood pressure, or other acute / chronic illness, I acknowledge that I should seek qualified specialist medical advice before considering joining the trip.
